**EMERGENCY POWERS ACT
(CAP. 11)**

**EMERGENCY POWERS (COVID-19)(No. 3) REGULATIONS 2020
EMERGENCY POWERS (COVID-19)(EXTENSION OF
QUARANTINE)(NO. 5) ORDER 2020**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 22A of *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), being satisfied that it is necessary to do so to prevent the transmission of COVID-19 within Solomon Islands, make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Extension of Quarantine)(No. 5) Order 2020*.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Extension of quarantine

The quarantine period of each person specified in the Schedule (who are persons who entered Solomon Islands on 25 October) is extended for 7 days ending on 14 November 2020.

4 Testing of persons whose quarantine extended under paragraph 4

Each person whose quarantine period is extended under paragraph 4 must be tested for the presence of COVID-19 on 13 November 2020, and must test negative for COVID-19 for the test.
