**EMERGENCY POWER ACT  
(Cap. 11)**

**EMERGENCY POWERS (COVID-19)(No. 3) REGULATIONS 2020**

**EMERGENCY POWERS (COVID-19)(EXTENSION OF  
QUARANTINE)(NO. 6) ORDER 2020**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 22A of *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), being satisfied that it is necessary to do so to prevent the transmission of COVID-19 within Solomon Islands, make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Extension of Quarantine)(No. 6) Order 2020*.

**2 Commencement**

This Order commences on the day it is published in the Gazette.

**3 Definition**

In this Order:

“*extended quarantine period*” means the period for which a quarantine period is extended under paragraph 4.

**4 Extension of quarantine**

- (1) The quarantine period of each person specified in Schedule 1 is extended for 8 days ending on 23 November 2020.
- (2) The quarantine period of each person specified in Schedule 2 is extended for 9 more days ending on 23 November 2020, and each of those persons must be quarantined at a quarantine station during that 9-day period.
- (3) The quarantine period of each person specified in the Schedule 3 is extended for 21 days ending on 3 December 2020.

**5 Testing of persons whose quarantine paragraph 4(1) and (2) extended under**

Each person whose quarantine period is extended under paragraph 4(1) or

- (2) must be tested for the presence of COVID-19:
  - (a) on 18 November 2020; and
  - (b) on 22 November 2020.
- (2) Each of those persons must test negative for COVID-19 for both tests.

**6 Testing of persons whose quarantine extended under paragraph 4(3)**

- (1) Each person whose quarantine period is extended under paragraph 4(3) must be tested for the presence of COVID-19:
  - (a) on 19 November 2020; and
  - (b) on 26 November 2020; and
  - (c) on 2 December 2020.
- (2) Each of those persons must test negative COVID-19 for each of the 3 tests.
