**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 43) ORDER 2020**

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 6(2) of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 43) Order 2020*.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

The following persons may enter Solomon Islands on 18 November 2020 and on 19 November 2020 despite the prohibition under regulation 6(2) of the Regulations:

- (1) Kelvin Ross McDonald;
- (2) Claudia Louise Walding;
- (3) Glen Cyril Elliott Solly;
- (4) Susan Jean Henry;
- (5) Troy Andrew Bayfield;
- (6) Deborah Denise Rasmussen;
- (7) Warren Danford Michael.

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM
QUARANTINE PERIOD)(NO. 17) ORDER 2020**

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 17) Order 2020*.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

(1) The following persons are exempted from being quarantined at quarantine station for the quarantine period when they enter Solomon Islands on 18 November 2020 and 19 November 2020:

- (a) Kelvin Ross McDonald;
- (b) Claudia Louise Walding;
- (c) Glen Cyril Elliott Solly;
- (d) Susan Jean Henry;
- (e) Troy Andrew Bayfield
- (f) Deborah Denise Rasmussen;
- (g) Warren Danford Michael.

(2) The exemption under subparagraph (1) is subject to the condition that each person exempted must, while in Solomon Islands:

- (a) maintain physical isolation from any other person; and
- (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
- (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the

Government's quarantine procedures.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

The following persons may enter Solomon Islands on 19 November 2020 despite the prohibition under regulation 6(1) of the Regulation :

- (2) Philip Michael Drew.

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 18) ORDER 2020

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 18) Order 2020*.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

- (1) The following persons are exempted from being quarantined at quarantine station for the quarantine period when they enter Solomon Islands on 19 November 2020:
 - (a) Helen Marie Nolan;
 - (b) Philip Michael Drew.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must:
 - (a) on entry into Solomon Islands give to an immigration officer a report certifying that:
 - (i) the person has not been outside Kiribati at any time during the 21 day period immediately before the day the person travels to Solomon Islands; and
 - (ii) Kiribati is a country where there has never been confirmed case of a person infected with COVID-19; and
 - (b) while in Solomon Islands:
 - (i) maintain physical isolation from any other person; and
 - (ii) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from an other person;

and

- (iii) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
