**CORRECTIONAL SERVICES ACT 2007****CORRECTIONAL SERVICES (PAROLE) (AMENDMENT) (NO. 2)  
REGULATIONS 2020**

In exercise of the powers conferred by section 75 of the *Correctional Services Act 2007* (Act No. 8 of 2007), the Minister for Police, National Security and Correctional Services makes the following Regulations:

- 1 Citation**  
These Regulations may be cited as the *Correctional Services (Parole) (Amendment) (No. 2) Regulations 2020*.
- 2 Commencement**  
These Regulations commence on the date they are published in the Gazette.
- 3 Amendment of Correctional Services (Parole) Regulations 2014**  
These Regulations amend the *Correctional Services (Parole) Regulations 2014* (LN 47/1 4) (“*Principal Regulations*”).
- 4 Repeal and replacement of Schedule 2**  
The Principal Regulations are amended by repealing Schedule 2 and replacing it with:

**PRICE CONTROL ACT**  
 (CAP. 64)

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION  
 OF PRICES) (AMENDMENT) (NO. 18) ORDER 2020**

I, Hon. Clezy Rore. Minister for Commerce, industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

1. This Order is the *Price Control (Application to Goods and Restriction of Prices) Amendment (No. 18) Order 2020*.
2. This Order commences on 1 October 2020.
3. The *Price Control (Application to Good and Restriction of Prices) Order 1987* (Cap. 64, Legal Notice. 47 of 1987), is amended in Schedule 3 by revoking serial No. 13 (Petroleum Products) and substituting the following:

**“13 PETROLEUM PRODUCTS**

	<b>WHOLESALE</b> (Maximum price \$ per Kg)	<b>RETAIL</b> (Maximum price \$ per Kg)
<b>PETROLEUM PRODUCTS</b>		
(a) Petroleum Products - (PMS)	522.98	686.4

(c) Kerosene - (KERO)	613.1	(maximum percentage mark-up) - cost into store plus 15% for sales of packaged product.
