EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020**EMERGENCY POWERS (COVID-19) (DECLARATION OF QUARANTINE STATIONS) (AMENDMENT) (NO. 10) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), and with reference to sections 36 and 65(2) of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the Emergency Powers (COVID-19) (Declaration of Quarantine Stations) (Amendment) (No. 10) Order 2021.

2 Commencement

This Order commences on the day this Order is published in the Gazette.

3 Amendment of Emergency Powers (COVID-19) (Declaration of Quarantine Stations) Order 2020

This Order amends the *Emergency Powers (COVID-19) (Declaration of Quarantine Stations) Order 2020* (Legal Notice No. 35 of 2020) (“**Principal Order**”).
