EMERGENCY POWERS ACT

EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020

EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 57) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(2) of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 57) Order 2021.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

Each of the following persons may enter Solomon Islands on 21 January 2021 despite the prohibition under regulation 7(1) of the Regulations:

- (a) Stephen de Maria;
- (b) Paul Robinson.

EMERGENCY POWERS ACT

EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 27) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 9 of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 27) Order 2021.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

- (1) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 21 January 2021:
 - (a) Stephen de Maria;
 - (b) Paul Robinson.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
 - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
