PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 2) ORDER 2021

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1. This Order is the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 2) Order 2021.
- 2. This Order commences on the date this Order is published in the Gazette.
- 3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Cap 64, LN 4 7 of 1987) is amended in Schedule 3 by deleting the item for serial No.12 (Liquid Petroleum Gas) and substituting:
