**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION
OF PRICES) (AMENDMENT) (NO. 2) ORDER 2021**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

1. This Order is the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 2) Order 2021.
2. This Order commences on the date this Order is published in the Gazette.
3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Cap 64, LN 4 7 of 1987) is amended in Schedule 3 by deleting the item for serial No.12 (Liquid Petroleum Gas) and substituting:

“12 LIQUID PETROLEUM GAS

	WHOLESALE (Maximum price per kg) \$	RETAIL (Maximum price per kg) \$
(a) Propane	21.37	23.22

Note:

15% Goods Tax and 10% Retailers Margin inclusive.”

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION
OF PRICES) (AMENDMENT) ORDER 2021**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

1. This Order is the Price Control (Application to Goods and Restriction of Prices) (Amendment) Order 2021.
2. This Order commences on the date this Order is published in the Gazette.
3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (LN 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 13 (Petroleum Products) and substituting:

“13 PETROLEUM PRODUCTS

	WHOLESALE (Maximum price in S.I. cents per litre)	R E T A I L (Maximum price in S.I. cents per litre)
(a) Petroleum motor spirit -(PMS)	559.29	728.2
(b) Distillate -(ADO)	556.56	736.5
(c) Kerosene-(KERO)	503.93	(Maximum percentage mark-up) - cost into store plus 15% for sales of packaged product -cost into store plus 20% for break bulk sales.”
