MINES AND MINERALS ACT
(Cap. 42)

MINES AND MINERALS (AMENDMENT) REGULATIONS 2020

I, Hon. Bradley Tovosia, Minister for Mines, Energy and Rural Electrification, under section 80 of the *Mines and Minerals Act* (Cap. 42), make the following regulations:

1 Citation

These Regulations may be cited as the Mines and Minerals (Amendment) Regulations 2020.

2 Commencement

These Regulations commence on the date appointed by the Minister by notice in the Gazette.

3 Amendment of Mines and Minerals Regulations 1996

These Regulations amend the Mines and Minerals Regulations 1996 (Cap. 42, LN 106/1996) (“Principal Regulations”).

4 Regulation 22 amended

Regulation 22 of the Principal Regulations is amended:

- (a) by inserting “(1)” before “Application”; and
- (b) by omitting “Schedule” and substituting “Third Schedule”; and

(c) by inserting at the end:

“(2) In the Third Schedule, “km²” includes the remaining part of an area after the area is divided into km² which is less than a km².”.

5 **Repeal of clause 11 of Second Schedule**

Clause 11 of the Second Schedule of the Principal Regulations entitled “Mineral Export Permit and Consignment Permit Fees” is repealed.

6 **Repeal and replacement of Third Schedule**

The Principal Regulations are amended by repealing the third Schedule and replacing it with:

 - (i) for the first year, \$1,000 per km²; or
 - (ii) for the second year, \$1,500 per km²; or
 - (iii) for the third year, \$2,000 per km²; or
 - (iv) for the fourth year, \$2,500 per km²; or
 - (v) for the fifth year:
 - (A) 25% more than the fee paid for the fourth year; and
 - (B) \$2,000 per km²; or
 - (vi) for each subsequent year:
 - (A) 25% more than the fee paid for the immediately previous year; and
 - (B) \$500 more per km² than was paid the immediately previous year; or
 - (b) if the applicant has previously held a reconnaissance permit in respect of the area:
 - (i) for the first year, \$1,000 per km²; or
 - (ii) for each subsequent year, \$500 more per km² than was paid the immediately previous year.
- (3) Annual fee for prospecting licence (including if renewed) for an area that is more than 20 km²:
 - (a) for the first year:
 - (i) \$10,000; and
 - (ii) \$200 per km² by which the area exceeds 20 km²; or
 - (b) for second year:

- (i) \$12,500; and
 - (ii) \$400 per km² by which the area exceeds 20 km²; or
 - (c) for the third year:
 - (i) \$15,000; and
 - (ii) \$600 per km² by which the area exceeds 20 km²; or
 - (d) for the fourth year:
 - (i) \$17,500; and
 - (ii) \$800 per km² by which the area exceeds 20 km²; or
 - (e) for the fifth year:
 - (i) 25% more than the fee paid for the fourth year; and
 - (ii) \$1,000 per km²; or
 - (f) for each following subsequent year:
 - (i) 25% more than the fee paid for the immediately previous year; and
 - (ii) \$200 more per km² than was paid the immediately previous year.
- (4) Damage deposit:
- (a) \$15,000 for an area that is twenty km² or less; or
 - (b) for an area that is more than 20 km²:
 - (i) \$15,000; and
 - (ii) \$1,000 per km² by which the area exceeds 20 km².
- (5) Renewal of prospecting Licence:
- (a) application fee \$5,000
 - (b) processing fee (including plans) \$5,000.

5. Mining lease

- (1) Application for mining lease:
 - (a) application fee \$30,000
 - (b) processing fee (including plans) \$30,000.
- (2) Annual fee for mining lease (including if renewed) \$1,000,000.
- (3) Renewal of mining lease:
 - (a) application for renewal \$30,000
 - (b) processing fee (including plans) \$30,000.
