# EMERGENCY POWERS (COVID-19)(No. 4) REGULATIONS 2020

# EMERGENCY POWERS (COVID-19)(EXTENSION OF QUARANTINE)(NO. 9) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 29 of *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), being satisfied that it is necessary to do so to prevent the transmission of COVID-19 within Solomon Islands, make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers* (COVID-19)(Extension of Quarantine)(No. 9) Order 2021.

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

# **3** Extension of quarantine

The quarantine period of each of the persons specified in the Schedule is extended for 2 more days ending on 15 February 2021, and each of those persons must be quarantined at a quarantine station during that 2-day period:

4 Testing of persons whose quarantine extended under paragraph 3

Each person whose quarantine period is extended under paragraph 3 must be tested for the presence of COVID-19 on 14 February 2021, and must test negative for COVID-19 for the test.

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

#### **3** Extension of quarantine

1 Citation

This Order may be cited as the *Emergency Powers* (COVID-19)(Extension of Quarantine)(No. 11) Order 2021.

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

#### **3** Extension of quarantine

The quarantine period of each person specified in the Schedule is extended for 10 more days ending on 21 February 2021, and each of those persons must be quarantined at a quarantine station during that 10-day period.
