EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020

EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 67) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(2) of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 67) Order 2021.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

- (1) Each of the following persons, who are delivering a new Twin Otter aircraft for Solomon Airlines and are due to arrive in Solomon Islands on 12 February 2021, may enter Solomon Islands to deliver that aircraft despite the prohibition under regulation 7(1) of the Regulations:
 - (a) Daniel Gordon Irvin;
 - (b) Anthony Scott Tripp.

4 Expiry

This Order expires on 15 February 2021.

EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 32) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 9 of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (legal Notice 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exemption from Quarantine Period) (No. 32) Order 2021.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

- (1) Each of the following persons, due to enter Solomon Islands on 12 February 2021 to deliver a new aircraft for Solomon Airlines, is on entering Solomon Islands exempted from being quarantined at a quarantine station for the quarantine period:
 - (a) Daniel Gordon Irvin;
 - (b) Anthony Scott Tripp.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
 - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
