**CUSTOMS AND EXCISE ACT**

(Cap. 121)

**CUSTOMS (AMENDMENT) RULES 2021**

I, Hon. Harry Kuma, Minister for Finance and Treasury under section 275 of the *Customs and Excise Act* (Cap. 121), make the following Rules:

**1 Citation**

These Rules may be cited as the *Customs (Amendment) Rules 2021*.

**2 Commencement**

These Rules commence on the date of publication in the Gazette.

**3 Amendment to Schedule of the *Customs Rules* (Cap. 121)**

These Rules amend the Customs Rules (Cap. 121 ) (“*Principal Rules*”).

**4 Schedule Amended**

(1) Clause 1 in the Schedule to the Principal Rules is amended by:

- (a) deleting “fifteen dollars” and substituting “\$40.98”; and
- (b) deleting “twenty dollars” and substituting “\$54.64”.

(2) The Schedule to the Principal Rules is amended by deleting clause 5 and substituting the following:

“(5) The scale of charges are as follows:

## RENT FOR GOODS STORED IN A QUEEN'S WAREHOUSE

- (i) For each consignment of goods, not exceeding one half of a metric tonne \$4.10 for the first ten days, per day or part of a day, and after the first ten days \$5.46 for each day or part of a day.
- (ii) For each consignment of goods, exceeding one half of a metric tonne but not one metric tonne \$5.46 for the first ten days, per day or part of a day, and after the first ten days \$6.83 for each day or part of a day.
- (iii) For each metric tonne or part of a metric tonne in excess of the first metric tonne \$6.83 for the first ten days, per day or part of a day and \$8.15 for each day or part of a day.”

**PRICE CONTROL ACT**  
(Cap. 64)

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 5) ORDER 2021**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

1. This Order is the Price Control (*Application to Goods and Restriction of Prices*) (*Amendment*) (*No. 5*) *Order 2021*.
2. This Order commences 1 March 2021.
3. The Price Control (*Application to Goods and Restriction of Prices*) Order 1987 (LN 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 13 (Petroleum Products) and substituting:

**“13 PETROLEUM PRODUCTS**
