EMERGENCY POWERS ACT

(Cap. 11)

EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 73) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(2) of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 73) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

- (1) Each person specified in Schedule 1 may enter Solomon Islands under regulation 7(2) of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* despite the prohibition under regulation 7(1) of the *Regulations*.
- (2) In addition, each person specified in Schedule 2 may enter Solomon Islands under regulation 7(3) of the *Regulations*.

4 Expiry

This Order expires on 18 May 2021.
