EMERGENCY POWERS ACT

(Cap. 11)

EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 75) ORDER 2021**

I, Hen. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(2) of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 75) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each of the following persons may enter Solomon Islands on 14 March 2021 and 16 March 2021 despite the prohibition under regulation 7(1) of the Regulations:

- (a) Paul John Robinson;
- (b) Claudia Louise Walding;
- (c) Glen Cyril Elliott Solly;
- (d) Helen Rose Piringisau;
- (e) Primula Sipolo;
- (f) Anna Muamao Michael;
- (g) Benzer Tahuiraho.

EMERGENCY POWERS ACT

EMERGENCY POWERS (COVID-19)(NO. 4) REGULATIONS 2020**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM
QUARANTINE PERIOD)(NO. 33) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 9 of the *Emergency Powers (COVID-19)(No. 4) Regulations 2020* (Legal Notice 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 33) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 14 March 2021 and 16 March 2021:
 - (a) Paul John Robinson;
 - (b) Claudia Louise Walding;
 - (c) Glen Cyril Elliott Solly;
 - (d) Helen Rose Piringisau;
 - (e) Primula Sipolo;
 - (f) Anna Muamao Michael;
 - (g) Benzer Tahuiraho.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
 - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
