EMERGENCY POWERS (COVID-19) (NO.4) REGULATIONS 2020

**EMERGENCY POWERS (COVID-19) (EXEMPTION FROM
QUARANTINE PERIOD) (NO. 35) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 9 of the *Emergency Powers (COVID-19) (No. 4) Regulations 2020* (Legal Notice No. 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exemption from Quarantine Period) (No. 35) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

(1) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 16 March 2021:

- (a) Paul John Robinson;
- (b) Claudia Louise Walding;
- (c) Glen Cyril Elliott Solly.

(2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:

- (a) maintain physical isolation from any other person; and
- (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other persons; and
- (c) be transported from Honiara International Airport to the Heritage Park Hotel and from the hotel to the airport, in accordance with Governments quarantine procedures.

4 Amendment of Emergency Powers (COVID-19) (Exemption from Quarantine Station) (No. 33) Order 2021 (Legal Notice No. 70 of 2021)

This Order amends the *Emergency Powers (COVID-19) (Exemption from Quarantine Station) (No. 33) Order 2021* (Legal Notice No. 70 of 2021)

by omitting from paragraph 3(1) “and 16 March 2021”.

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 36) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Tyler Deitric is exempted from being quarantined at a quarantine station for the quarantine period when he enters Solomon Islands on 16 March 2021.
- (2) The exemption under subparagraph (1) is subject to the condition that the person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in the National Referral Hospital in a manner that physically isolates the person from any other person; and
 - (c) be transported to and from the Hospital in accordance with the Government’s quarantine procedures.
