**EMERGENCY POWERS ACT**

(Cap. 11)

**EMERGENCY POWERS (COVID-19) REGULATIONS 2021****EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 81) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 81) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-citizens who may enter Solomon Islands**

- (1) Each person specified in Schedule 1 may enter Solomon Islands under regulation 7(2) of the *Emergency Powers (COVID-19) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.
- (2) In addition, each person specified in Schedule 2 may enter Solomon Islands under regulation 7(3) of the Regulations.

**4 Expiry**

This Order expires on 30 June 2021.

#### **EMERGENCY POWERS (COVID-19) REGULATIONS 2021**

#### **EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD )(NO. 39) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice 84 of 2021), make the following Order:

#### **1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 39) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Exemption from quarantine period**

- (1) Each person specified in Schedule 1 is exempted from being quarantined at a quarantine station for the quarantine period when the person enters Solomon Islands on 2 April 2021.
- (2) Each person specified in Schedule 2 is exempted from being quarantined at a quarantine station for the quarantine period when the person enters Solomon Islands on 5 April 2021.
- (3) The exemptions under subparagraphs (1) and (2) are subject to the condition that each person exempted must while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
  - (c) be transported to and from the Heritage Park Hotel in accordance with the Government's quarantine procedures.

QUARANTINE PERIOD )(NO. 40) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice 84 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 40) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Exemption from quarantine period**

- (1) Benzer Tahuiraho is exempted from being quarantined at a quarantine station for the quarantine period due to end on 6 April 2021.
- (2) The exemption under subparagraph (1) is subject to the condition that the person exempted must:
  - (a) not be released from quarantine before 10 pm on 5 April 2021; and
  - (b) until the person's departure from Solomon Islands on 6 April 2021:
    - (i) maintain physical isolation from any other person; and
    - (ii) be transported from the person's accommodation to the Honiara International Airport in accordance with the Government's quarantine procedures.
