**EMERGENCY POWERS (COVID-19) REGULATIONS 2021****EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY  
INTO SOLOMON ISLANDS) (NO. 86) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 86) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-citizens who may enter Solomon Islands**

Nguyen Binh Nhuong may enter Solomon Islands on or about the date this Order commences despite the prohibition under regulation 7(1) of the Regulations.

**EMERGENCY POWERS (COVID-19) REGULATIONS 2021****EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY  
INTO SOLOMON ISLANDS) (NO. 88) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021),

make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 88) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-citizens who may enter Solomon Islands**

- (1) Each person specified in Schedule 1 may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.
- (2) In addition, each person specified in Schedule 2 may enter Solomon Islands under regulation 7(4) of the Regulations.

**4 Expiry**

This Order expires on 8 October 2021.

**EMERGENCY POWERS (COVID-19) REGULATIONS 2021**

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM  
QUARANTINE PERIOD )(NO. 42) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice 84 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 42) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Exemption from quarantine period**



- (1) Nguyen Binh Nhuong is exempted from being quarantined at a quarantine station for the quarantine period when the person enters Solomon Islands for medical examination and treatment on or about the date this Order commences.
- (2) The exemption under subparagraph (1) is subject to the condition that the person exempted must while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in Gizo hospital; and
  - (c) be transported from the vessel MV Serenity to Gizo Hospital, and from the hospital to the MV Serenity, in accordance with the Government's quarantine procedures.
