**LAW REFORM COMMISSION ACT**

(Cap. 15)

**APPOINTMENT OF COMMISSIONERS**

I, Hon. Clezy Rore, Minister for Justice and Legal Affairs:

- (a) under sections 3(2)(b) and (3) and 4(2) of the *Law Reform Commission Act* (Cap. 15), appoint each of the following persons to be a Commissioner on a part-time basis for four years:
  - (i) Anika Kingmele, a person who appears to me to have knowledge and interest in criminal administration;
  - (ii) Atenasi Jacinta Ata, a person who appears to me to have knowledge and interest in sociology and Solomon Islands culture; and
- (b) for section 4(4) of the *Law Reform Commission Act* (Cap. 15), specify that the following salary and allowances are payable to the Commissioners:
  - (i) if the Commissioner attends a meeting, workshop, conference or seminar to carry out duties for performing the Commission's functions, a sitting allowance of \$1,000.00 for each day or part of a day that the Commissioner attends the meeting, workshop, conference or seminar;
  - (ii) if the Commissioner travels outside of Honiara to another area in Solomon Islands to carry out duties for performing the Commission's functions, a subsistence allowance of \$200.00 for each day or part of a day that the Commissioner is outside of Honiara;
  - (iii) except if the Commissioner's appointment is terminated for misconduct or because the Commissioner has been convicted of a criminal offence:
    - (A) an amount payable in a lump sum at the end of the Commissioner's term of office of \$15,000 for four years; or
    - (B) if the Commissioner holds office for less than four years, the amount payable in a lump sum when the Commissioner ceases to hold office equivalent to the sum of \$3,750 for each year the Commissioner held office.

**PRICE CONTROL ACT**  
 (Cap. 64)

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION  
 OF PRICES) (AMENDMENT) (NO. 8) ORDER 2021**

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64 ), make the following Order:

1. This Order is the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 8) Order 2021.
2. This Order commences on 15 April 2021.
3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Cap 64, LN 47 of 1987) is amended in Schedule 3 by deleting the item for serial No. 12 (Liquid Petroleum Gas) and substituting:
