EMERGENCY POWERS (COVID-19) REGULATIONS 2021**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 103) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 103) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each person specified in the Schedule may enter Solomon Islands on 9 May 2021 despite the prohibition under regulation 7(1) of the Regulations.
