EMERGENCY POWERS (COVID-19) REGULATIONS 2021**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY
INTO SOLOMON ISLANDS) (NO. 108) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 108) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

- (1) Giles Teerite may enter Solomon Islands under on 18 May 2021 despite the prohibition under regulation 7(1) of the Regulations.
- (2) Jeff Jong may enter Solomon Islands on 18 May 2021, 19 May 2021 and on 20 May 2021 despite the prohibition under regulation 7(1) of the Regulations.
- (3) Bitia Tekiabon and Banian Kiboboua may enter Solomon Islands on, 19 May 2021 and on 20 May 2021 despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM
QUARANTINE PERIOD)(NO.50) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice 84 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 50) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Giles Teerite is exempted from being quarantined at a quarantine station for the quarantine period when he enters Solomon Islands on 18 May 2021.
- (2) Jeff Jong is exempted from being quarantined at a quarantine station for the quarantine period when he enters Solomon Islands on 18 May 2021 and 19 May 2021.
- (3) Bitia Tekiabon and Banian Kiboboua are exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 19 May 2021.

4 Condition of exemption

The exemptions under paragraph 3(1), (2) and (3) are subject to the condition that each person exempted must while in Solomon Islands:

- (a) maintain physical isolation from any other person; and
- (b) be accommodated in Honiara at the Honiara Hotel in a manner that physically isolates the person from any other person; and
- (c) be transported to the Honiara Hotel from Honiara International Airport, and from the Hotel to the Airport, in accordance with the Government's quarantine procedures.
