EMERGENCY POWERS ACT (CAP. 11)

EMERGENCY POWERS (COVID-19) REGULATIONS 2021

EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 93) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 93) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each person specified in the Schedule may enter Solomon Islands despite the prohibition under regulation 7(1) of the Regulations.

4 Expiry

This Order expires on 15 October 2021.
