EMERGENCY POWERS ACT

(Cap. 11)

EMERGENCY POWERS (COVID-19) REGULATIONS 2021

EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 91) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021), and with reference to sections 36 and 65 of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 91) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each of the following persons may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations:

- (a) Ken Fah Chun;
- (b) Ravi Mahesh Ekanayake Wijetunge Herath Ekanayake Mudiyansele.

4 Amendment of Legal Notices 73 and 102 of 2021

- (1) The *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No 74) Order 2021* (Legal Notice 73 of 2021 published in Gazette No. 58 Supplement 54, 13 March 2021, page 185) is amended:
 - (a) by omitting “18 May 2021” from paragraph 4 and substituting “13 September 2021”; and
 - (b) by omitting from the Schedule the name that is item number 1.65.
- (2) The *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 88) Order 2021* (Legal Notice 102 of 2021 published in Gazette No. 85 Supplement 74, 9 April 2021, page 287) is amended by omitting from Schedule 1 the name that is item number 1.40.

5 Expiry

This Order expires on 8 October 2021.
