ELECTRICITY ACT

(Cap. 128)

**ELECTRICITY (CHARGES FOR SUPPLY)(NO. 2)
REGULATIONS 2021**

I, Hon. Bradley Tovosia, Minister for Mines, Energy and Rural Electrification, and I, Hon. Manasseh Damukana Sogavare, Minister for Finance and Treasury, under section 55(v) of the *Electricity Act* (Cap. 128) and with reference to section 26 of the *State Owned Enterprises Act 2007* (Act No. 7 of 2007), on the recommendation of the Authority, make the following Regulations:

1 Citation

These Regulations may be cited as the *Electricity (Charges for Supply)(No. 2) Regulations 2021*.

2 Commencement

These Regulations commence on 1 July 2021.

3 Definition

In these Regulations:

“non-regular customer” means a customer who owns a generation facility and

is connected through a kilowatt metre.

4 Charges for supply of electricity

The rates of charges for the supply of electricity from Authority public installations:

- (a) for prepaid customers are specified in Schedule 1; and
- (b) for postpaid customers are specified in Schedule 2; and
- (c) for non-regular customers are specified in Schedule 3.

5 Repeal

The Electricity (Charges for Supply) Regulations 2021 (Legal Notice No. 124 of 2021) are repealed.
