## **EMERGENCY POWERS (COVID-19) REGULATIONS 2021**

# EMERGENCY POWERS (COVID-19)(WAIVER OF PAYMENT OF FEE)(NO. 2) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 24(c) of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021) make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Waiver of Payment of Fee)(No. 2) Order 2021.* 

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

#### **3** Waiver of payment of fee for pre-departure test

Payment, by each of the persons specified in the Schedule (who are players and officials of the Kurukuru national futsal team which will be participating in the FIFA Futsal World Cup in Lithuania), of the fee for being tested for the presence of COVID-19 before leaving Solomon Islands to prepare for or participate in the tournament is waived.

Note:

The fee referred to in paragraph 3 is the fee prescribed by Emergency Powers (COVID-19)(Fee for Pre-departure Test)(No.2) Order 2021 (Legal Notice No. 92 of 2021).
