REGULATIONS 2021****EMERGENCY POWERS (COVID-19) (REVOCATION OF DECLARATION  
OF QUARANTINE STATION) (IMAGINATION ISLAND) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 11 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), and with reference to sections 36 and 65(2) of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Revocation of Declaration of Quarantine Station) (Imagination Island) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Revocation**

The *Emergency Powers (COVID-19)(Declaration of Quarantine Station) (Imagination Island) Order 2021* (Legal Notice 193 of 2021) is revoked.

REGULATIONS 2021****EMERGENCY POWERS (COVID-19) (DECLARATION OF  
QUARANTINE STATION) (NUSATUPE) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 11 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Declaration of Quarantine Station) (Nusatupe) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Declaration of quarantine station**

The area at Nusatupe, Gizo demarcated by lines with the co-ordinates specified in Schedule 1, and shown bounded by a black line with buildings with the designations “H1”, “H2” and “H3” on the plan in Schedule 2, is declared to be a quarantine station.

**4 Consequential amendment**

The *Emergency Powers (COVID-19) (Declaration of Quarantine Stations) (Western Province) Order 2020* (Legal Notice No. 183 of 2020) is amended by omitting item number 2 (Red Devil Transport, Nusatupe) from the table in the Schedule to the Order.
