**EMERGENCY POWERS ACT**

**EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021****EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY  
INTO SOLOMON ISLANDS) (NO. 140) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 140) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-citizen who may enter Solomon Islands**

Liu Rongcong may enter Solomon Islands on or about the date this Order is published in the *Gazette* despite the prohibition under regulation 7(1) of the Regulations.

**EMERGENCY POWERS ACT**

**EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021****EMERGENCY POWERS (COVID-19)(EXEMPTION FROM  
QUARANTINE PERIOD )(NO. 61) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the

*Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice 198 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 61) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Exemption from quarantine period**

- (1) Liu Rongcong is exempted from being quarantined at a quarantine station for the quarantine period when the person enters Solomon Islands for dental examination and treatment on or about the date this Order is published in the *Gazette*.
- (2) The exemption under subparagraph (1) is subject to the condition that the person exempted must while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in Honiara at the National Referral Hospital in a manner that complies with the Government's quarantine procedures; and
  - (c) be transported from the fishing vessel Southern Seas 01 to the National Referral Hospital, and from the National Referral Hospital to the fishing vessel, in accordance with the Government's quarantine procedures.
