**EMERGENCY POWERS ACT**  
(Cap. 11)

**EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021**

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 65) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice 198 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 65) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Exemption from quarantine period**

- (1) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period commencing from 14 August 2021:
  - (a) Reynaldo Soler;
  - (b) Lesley Mewa;
  - (c) Charles Hiro;
  - (d) Thomas Hisuota;
  - (e) Nazareth Israel Caneth Montes;
  - (f) Eddie Tuahaika;
  - (g) Howard Manehioha;
  - (h) Walter Otao;
  - (i) Sailas Congoro;
  - (j) Raymond Wale;
  - (k) Charlie Pride.
- (2) The exemption under subparagraph (1) is subject to the condition that each

person exempted must:

- (a) be tested for the presence of COVID-19 as soon as practicable after entering Solomon Islands on 14 August 2021; and
- (b) be tested for the presence of COVID-19 again on 17 August 2021; and
- (c) test negative for COVID-19 for each of those tests; and
- (d) remain on board the fishing vessel MV Solomon Emerald, and maintain physical isolation from any person who is not a member of the crew of the vessel or an authorised officer who boards the vessel to carry out his or her duties, until the results of the 2 tests are known.
