EMERGENCY POWERS ACT (CAP. 11)

EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 149) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), and with reference to sections 36 and 65 of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 149) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each of the persons specified in the Schedule may enter Solomon Islands on or about 6 October 2021 despite the prohibition under regulation 7(1) of the Regulations:

- (a) Justin Mark Anning;
- (b) Andrew Michael Dunn;
- (c) Bernard Rakocevic;
- (d) Joshua Pierre Raymond;
- (e) Luke Matthew Rogers;
- (f) Benjamin Noel Yip.

4 Revocation

The *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 143) Order 2021* (Legal Notice 219 of 2021) is revoked.

EMERGENCY POWERS ACT (CAP. 11)

EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 67) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 67) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period on entering Solomon Islands on or about 6 October 2021:
 - (a) Justin Mark Anning;
 - (b) Andrew Michael Dunn;
 - (c) Bernard Rakocevic;
 - (d) Joshua Pierre Raymond;
 - (e) Luke Matthew Rogers;
 - (f) Benjamin Noel Yip.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must:
 - (a) have complied with regulation 31(2) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* before he or she began travelling to Solomon Islands; and
 - (b) have remained on board the vessel MV Calypso for the 21-day period commencing on the vessel's departure from Australia on 15 September 2021 and comprising 7 days at sea while travelling to Solomon Islands and 14 days moored in the Port of Honiara, and
 - (c) during the 21-day period specified in paragraph (b), have maintained physical isolation from any other vessel and any person who is not a member of the crew or an authorised officer who boards the vessel to

carry out his or her duties; and

- (d) during the 14-day period while moored in the Port of Honiara, have been tested for the presence of COVID-19 twice; and
- (e) have tested negative for COVID-19 for each of those tests.

4 Revocation

The *Emergency Powers (COVID-19)(Exemption from Quarantine Period) (No. 64) Order 2021* (Legal Notice 220 of 2021) is revoked.
