EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 165) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), and with reference to sections 36 and 65 of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 165) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Persons who may enter Solomon Islands

Each of the persons specified in the Schedule may enter Solomon Islands on or about 25 September 2021 despite the prohibition under regulation 7(1) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021*.

4 Revocation

The *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 161) Order 2021* (Legal Notice 251 of 2021) is revoked.
