EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 168) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 168) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizen who may enter Solomon Islands

Kieren Alex Hudson may enter Solomon Islands on or about 5 October 2021 despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE
PERIOD)(NO. 73) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 73) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Keiren Alex Hudson is exempted from being quarantined at a quarantine station for the quarantine period on entering Solomon Islands on or about 5 October 2021.
- (2) The exemption under subparagraph (1) is subject to the condition that the person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in Honiara at the Pacific Casino Hotel in a manner that physically isolates the person from any other person; and
 - (c) be transported to the Pacific Casino Hotel from Honiara International Airport, and from the Hotel to the Airport, in accordance with the Government's quarantine procedures.
