EMERGENCY POWERS ACT (Cap. 11)

EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 177) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 177) Order 2021.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

- Each person specified in Schedule 1 may, on 26 October 2021, enter Solomon Islands under regulation 7(4) of the *Emergency Powers (COVID-19) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.
- (2) In addition to subregulation (1), each of the person specified in Schedule 2 may on 26 October 2021, enter Solomon Islands under regulation 7(3).
