**EMERGENCY POWERS ACT**  
(Cap. 11)

**EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021**

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO  
SOLOMON ISLANDS) (NO. 178) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 178) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-citizens who may enter Solomon Islands**

- (1) Each person specified in Schedule 1 may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.
- (2) In addition, each person specified in Schedule 2 may enter Solomon Islands under regulation 7(4) of the Regulations.

**4 Expiry**

This Order expires on 20 April 2022.
