EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 187) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 187) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Persons who may enter Solomon Islands

Each person specified in the Schedule may enter Solomon Islands on or about 4 November 2021, despite the prohibition under regulation 7(1) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021*.
