#### **EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021**

### EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 189) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 189) Order 2021.* 

#### 2 Commencement

This Order commences on the day it is published in the *Gazette*.

#### 3 Non-citizens who may enter Solomon Islands

- (1) Each person specified in Schedule 1 may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.
- (2) In addition, each person specified in Schedule 2 may enter Solomon Islands under regulation 7(4) of the Regulations.

#### 4 Expiry

This Order expires on 5 May 2022.
