# EMERGENCY POWERS ACT (Cap. 11)

# EMERGENCY POWERS (COVID-19) (No. 2) REGULATIONS 2021

# EMERGENCY POWERS (COVID-19)(EXTENSION OF QUARANTINE) (NO. 14) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 33(1)(b) of *Emergency Powers (COVID-19)(No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), being satisfied that it is necessary to do so to prevent the transmission of COVID-19 within Solomon Islands, make the following Order:

## 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Extension of Quarantine)(No. 14) Order 2021.* 

## 2 Commencement

This Order commences on the day it is published in the Gazette.

# 3 Extension of quarantine

- (1) The quarantine period of each person specified in Schedule 1 is extended from 7 November 2021 for a further period of 4 days, ending on 11 November 2021.
- (2) The quarantine period of each person specified in Schedule 2 is extended from 7 November 2021 for one day, ending on 8 November 2021.
- (3) Each of those persons whose quarantine period is extended under subparagraph (1) or (2) must be quarantined at a quarantine station during the extended quarantine period.

# 4 Testing of persons whose quarantine extended under paragraph 3(1)

Each person whose quarantine period is extended under paragraph 3(1) must be tested once for the presence of COVID-19 during the extension, and must test negative for the test.

# 5 Testing of persons whose quarantine extended under paragraph 3(2)

Each person whose quarantine period is extended under paragraph 3(2) is not required to be tested for the presence of COVID-19 during the extension.
