EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 201) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 201) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Salote Vuniwaqa Mataitini and Giles Teerite may, on 24 November 2021, enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No.2) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE
PERIOD)(NO. 80) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the

Emergency Powers (COVID-19) (No. 2) Regulations 2021 (Legal Notice 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 80) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Each of the following persons is exempted from being quarantined at a quarantine station for the quarantine period when the person enters Solomon Islands on 24 November 2021:
 - (a) Salote Vuniwaqa Mataitini;
 - (b) Giles Teerite.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person (apart from an authorised officer); and
 - (b) be accommodated in Honiara at the Honiara Hotel or the King Solomon Hotel in accordance with the Government's quarantine procedures; and
 - (c) be transported from the Honiara International Airport to the hotel where they will be accommodated, and from the hotel to the Airport, in accordance with the Government's quarantine procedures.

EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 203) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(4A)(b) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 203) Order 2021*.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Persons who may enter Solomon Islands

Each of the following persons may enter Solomon Islands on 24 November 2021, despite the prohibition under regulation 7(1) of the Emergency Powers (COVID-19) (No. 2) Regulations 2021:

- (a) Salote Vuniwaqa Mataitini;
- (b) Giles Teerite.
