EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 205) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 205) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Police force personnel, armed forces personnel and associated civilian personnel of Australia or another country, who enter to provide assistance under the Agreement made in 2017 between the Government of Solomon Islands and the Government of Australia Concerning the Basis for Deployment of Police, Armed Forces and Other Personnel to Solomon Islands, may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 82) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 82) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

Police force personnel, armed forces personnel and associated civilian personnel of Australia or another country, who enter to provide assistance under the Agreement made in 2017 between the Government of Solomon Islands and the Government of Australia Concerning the Basis for Deployment of Police, Armed Forces and Other Personnel to Solomon Islands, are exempted from being quarantined at a quarantine station for the quarantine period.

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(5)(b) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 206) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Persons who may enter Solomon Islands

Police force personnel, armed forces personnel and associated civilian personnel of Australia or another country, who enter to provide assistance under the Agreement made in 2017 between the Government of Solomon Islands and the Government of Australia Concerning the Basis for Deployment of Police, Armed Forces and Other Personnel to Solomon Islands, may enter Solomon Islands despite the prohibition under regulation 7(1) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021*:
