EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021**EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 207) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 207) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Personnel from the Papua New Guinea Defence Force, who enter Solomon Islands to provide assistance to the Government for a public purpose in accordance with the Government's request for assistance of the Government of Papua New Guinea, may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No.3) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD) (NO. 83) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period) (No. 83) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

Personnel from the Papua New Guinea Defence Force, who enter Solomon Islands to provide assistance to the Government for a public purpose in accordance with the Government's request for assistance of the Government of Papua New Guinea, are exempted from being quarantined at a quarantine station for the quarantine period.

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(5)(b) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 208) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Persons who may enter Solomon Islands

Personnel from the Papua New Guinea Defence Force, who enter to

provide assistance to the Government for a public purpose in accordance with the Government's request for assistance of the Government of Papua New Guinea, may enter Solomon Islands despite the prohibition under regulation 7(1) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021*:
