**PRESERVATION OF PUBLIC SECURITY ACT
(Cap. 27)**

**PRESERVATION OF PUBLIC SECURITY (NO. 2)
(AMENDMENT) REGULATIONS 2021**

I, Sir David Vunagi, the Governor-General, under section 3 of the *Preservation of Public Security Act* (Cap. 27), make the following Regulations:

1 Citation

These Regulations may be cited as the *Preservation of Public Security (No. 2) (Amendment) Regulations 2021*.

2 Commencement

These Regulations commence on the day they are published in the *Gazette*.

3 Amendment of Preservation of Public Security (No. 2) Regulations 2021

These Regulations amend the *Preservation of Public Security (No. 2) Regulations 2021* (Legal Notice 334 of 2021) (“**Principal Regulations**”).

4 Regulation 3 amended

Regulation 3 of the Principal Regulations is amended:

(a) by inserting after the definition of “**essential worker**”:

“**foreign vessel**” means a vessel that is not registered in Solomon Islands or is not entitled to fly the Solomon Islands flag;”;

(b) by inserting “(Legal Notice 324 of 2021)” in paragraph (a) of the

- definition of “*personnel of the visiting contingent*” after “2003”; and
- (c) by inserting “(Legal Notice 328 of 2021)” in paragraph (b) of the definition of “*personnel of the visiting contingent*” after “2003”; and
 - (d) by omitting the definition of “*vessel*” and substituting:
“*vessel*” means any ship, boat or craft used for travelling by water that is not a foreign vessel;”.

5 Regulation 7 amended

Regulation 7 of the Principal Regulations is amended:

- (a) by omitting from subregulation (1) “, between the hours of 7.00 pm and 6.00 am”; and
- (b) by omitting from subregulation (2) “, between the hours of 7.00 pm and 7.00 am,”.

6 Regulation 13 amended

Regulation 13 of the Principal Regulations is amended by inserting “(Legal Notice 333 of 2021) after “2021”.
