EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021

EMERGENCY POWERS (COVID-19) (REVOCATION OF VIMO APARTMENTS AS QUARANTINE STATION) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 11 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), and with reference to sections 36 and 65 of the Interpretation and General *Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Revocation of VIMO Apartments as Quarantine Station) Order 2021.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Revocation

The Emergency Powers (COVID-19)(Declaration of Quarantine Station) (VIMO Apartments) Order 2021 (Legal Notice No. 284 of 2021) is revoked.

EMERGENCY POWERS (COVID-19) (REVOCATION OF SA ACCOMMODATION AS QUARANTINE STATION) ORDER 2021

1 Citation
