**EMERGENCY POWERS (COVID-19) (REVOCATION OF VIMO
APARTMENTS AS QUARANTINE STATION) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 11 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), and with reference to sections 36 and 65 of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Revocation of VIMO Apartments as Quarantine Station) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Revocation

The *Emergency Powers (COVID-19) (Declaration of Quarantine Station) (VIMO Apartments) Order 2021* (Legal Notice No. 284 of 2021) is revoked.

**EMERGENCY POWERS (COVID-19) (REVOCATION OF SA
ACCOMMODATION AS QUARANTINE STATION) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 11 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of

2021), and with reference to sections 36 and 65 of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Revocation of SA Accommodation as Quarantine Station) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Revocation by amendment of Legal Notice No. 35 of 2020

The *Emergency Powers (COVID-19)(Declaration of Quarantine Stations) Order 2020* (Legal Notice No. 35 of 2020 as amended by Legal Notices Nos. 59, 77, 98, 101, 159 and 207 of 2020 and Nos 15, 89, 195, 262 and 336 of 2021) is amended by omitting from the table in the Schedule to the Order item number 24 (SA Accommodation).
