**PRESERVATION OF PUBLIC SECURITY ACT  
(Cap. 27)**

**PRESERVATION OF PUBLIC SECURITY  
(NO. 2) (AMENDMENT NO. 3) REGULATIONS 2021**

I, Sir David Vunagi, the Governor-General, under section 3 of the *Preservation of Public Security Act* (Cap. 27), make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Preservation of Public Security (No. 2) (Amendment No. 3) Regulations 2021*.

**2 Commencement**

These Regulations commence on the day they are published in the *Gazette*.

**3 Amendment of Preservation of Public Security (No. 2) Regulations 2021**

These Regulations amend the *Preservation of Public Security (No. 2) Regulations 2021* (Legal Notice 334 of 2021) (“*Principal Regulations*”).

**4 Regulation 7 amended**

Regulation 7 of the *Principal Regulations* is amended:

(a) by inserting after subregulation (3):

“(3A) On 5 December 2021:

(a) a vessel outside the Port of Honiara must not:

(i) enter the Port of Honiara; or

(ii) come along side or berth at a wharf that is located within the Port of Honiara or anywhere else on the coast of the emergency zone; or

- (iii) go on shore anywhere on the coast of the emergency zone;  
and
- (b) a vessel in the Port of Honiara:
  - (i) between the hours of 12.00 am and 6.00 am, must not:
    - (A) leave the Port of Honiara; or
    - (B) come along side or berth at a wharf that is located within the Port of Honiara or anywhere else on the coast of the emergency zone; or
    - (C) go on shore anywhere on the coast of the emergency zone; and
  - (ii) between the hours of 6:00 am and 4.00 pm:
    - (A) may leave the Port of Honiara; and
    - (B) must not come along side or berth at a wharf that is located within the Port of Honiara or anywhere else on the coast of the emergency zone; or
    - (C) must not go on shore anywhere on the coast of the emergency zone; and
  - (iii) after 4.00 pm, must not:
    - (A) leave the Port of Honiara; or
    - (B) come along side or berth at a wharf that is located within the Port of Honiara or anywhere else on the coast of the emergency zone; or
    - (C) go on shore anywhere on the coast of the emergency zone; and
- (c) the operator of a vessel must not permit or enable a person on board the vessel to disembark from the vessel and go ashore anywhere on the coast of the emergency zone.”; and
- (b) by omitting from subregulation (4) “5 December 2021” and substituting “6 December 2021”; and
- (c) by omitting from subregulation (4)(a)(i) “enter of leave” and substituting “enter or leave”.
