EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021**EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 216) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 216) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-Citizens who may enter Solomon Islands

- (1) Each person specified in the Schedule may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021*, despite the prohibition under regulation 7(1) of the Regulations.
- (2) In addition to sub paragraph (1), Katya Mileva Strahan may enter Solomon Islands under regulation 7(4) of the Regulations, despite the prohibition under regulation 7(1).
