PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES)(AMENDMENT)(NO. 23) ORDER 2021

IN exercise of powers conferred upon me by sections 4 and 6 of the Price Control Act, make this Order-

- This Order may be cited as the Price Control (Application to Goods and Restrictions of Prices) Amendment) (No. 23) Order 2020 and shall come into effect on the 2nd December, 2021.
