**EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021**

**EMERGENCY POWERS (COVID-19) (DECLARATION OF QUARANTINE  
STATION) (CHENG'S BUILDING) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 11 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19) (Declaration of Quarantine Station) (Cheng's Building) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Declaration of quarantine station**

The property in East Honiara known as Cheng's Building, and comprised of Parcel No. 192-007-40 and Parcel No. 192-007-41, is declared to be a quarantine station.

**1 Citation**
