EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021

EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 223) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 223) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each of the following non-citizens may, on 27 December 2021 and on 29 December 2021, enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations:

- (a) Kelvin Ross McDonald;
- (b) Michael Andrew Bentley;
- (c) Warren Danforth Michael;
- (d) Margaret Joan Mancini.

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands) (No. 224) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Persons who may enter Solomon Islands

Each of the following persons may, on 27 December 2021 and on 29 December 2021, enter Solomon Islands under regulation 7(5)(b) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations:

- (a) Kelvin Ross McDonald;
- (b) Michael Andrew Bentley;
- (c) Warren Danfort Michael;
- (d) Margaret Joan Mancini;
- (e) Christian ToiTo'ona;
- (f) Helen Rose Piringisau.

EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE
PERIOD)(NO. 87) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 87) Order 2021*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Each of the following persons are exempted from being quarantined at a quarantine station for the quarantine period when the person enters Solomon Islands on 27 December 2021 and on 29 December 2021:
 - (a) Kelvin Ross McDonald;
 - (b) Michael Andrew Bentley;
 - (c) Warren Danforth Michael;
 - (d) Margaret Joan Mancini;
 - (e) Christian Toito'ona;
 - (f) Helen Rose Pirigisau.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated at a hotel in Honiara in accordance with the Government's quarantine procedures; and
 - (c) be transported to the hotel from Honiara International Airport, and from the hotel to the Airport, in accordance with the Government's quarantine procedures.
