CUSTOMS AND EXCISE ACT

(Cap. 121)

CUSTOMS AND EXCISE (IMPORT DUTIES) (AMENDMENT)**(NO. 2) ORDER 2021**

I, Hon. Harry Degruit Kuma, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121), make the following Order:

1. Citation

This Order may be cited as *Customs and Excise (Import Duties) (Amendment) (No. 2) Order 2021*.

2. Commencement

This Order commences on the date this Order is published in the *Gazette*.

3. Amendment to the First Schedule of the Act

This Order amends the First Schedule to the *Customs and Excise Act* (Cap. 121) (*“the First Schedule”*).

4. Amendment of import duty rates of plastics and articles thereof

In this section VII of the First Schedule the import duty rates of tariff items listed in the Schedule are amended by omitting “10%” and substituting with “\$1.40 per kg”:
