# EMERGENCY POWERS ACT

#### (Cap. 11)

# EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021 EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO

**SOLOMON ISLANDS) ORDER 2022** 

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) Order 2022.* 

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

#### 3 Non-citizens who may enter Solomon Islands

- (1) Each person specified in Schedule 1 may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021*, despite the prohibition under regulation 7(1) of the Regulations.
- (2) In addition, the person specified in Schedule 2 may enter Solomon Islands under regulation 7(4) of the Regulations.

#### 4 Expiry

This Order expires on 5 July 2022.
