EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 10) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 10) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-Citizens who may enter Solomon Islands

Each of the person specified in the Schedule may enter Solomon Islands, under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021*, despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exemption from Quarantine Period) Order 2022*.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from Quarantine Period

- (1) Each of the person specified in the Schedule is exempted from being quarantined at the Heritage Park Hotel for the Quarantine Period starting, when each of the person specified in the Schedule enter Solomon Islands on 30 January 2022.
- (2) The exemption under paragraph (1) is subject to the condition that each of the person specified in the Schedule is subject to the condition that, each person:
 - (a) maintain physical isolation from any other person; and
 - (b) must wear a face mask on and from 30 January 2022 to 31 January 2022.
