EMERGENCY POWERS ACT

(Cap. 11)

EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021

EMERGENCY POWERS (COVID-19) (HONIARA EMERGENCY ZONE) (RESTRICTION OF MOVEMENT OF PERSONS) (NO. 3) (AMENDMENT) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 15 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), and with reference to sections 36(a) and 65(2) of the Interpretation and General Provisions Act (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Honiara Emergency Zone) (Restriction of Movement of Persons) (No. 3) (Amendment) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Amendment of Legal Notice No. 33 of 2022

This Order amends the *Emergency Powers (COVID-19) (Honiara Emergency Zone) (Restriction of Movement of Persons) (No. 3) Order 2022* (Legal Notice No. 33 of 2022) (“*Principal Order*”).

4 Paragraph 4 amended

The *Principal Order* is amended:

(a) by omitting paragraph 4(2) and substituting:

“(2) On and from 3.00 pm on Sunday 30 January 2022 until 8.00 am on Monday 31 January 2022, a person in the emergency zone must:

- (a) be at the person’s place of residence, and remain there; and
- (b) not leave or be away from the person’s place of residence.

(2A) On and from Monday 31 January 2022 until this Order is revoked, between the hours of 5.00 pm and 8.00 am, a person in the emergency zone must:

- (a) be at the person’s place of residence, and remain there; and

- (b) not leave or be away from the person's place of residence.”; and
- (b) by omitting from paragraph 4(3) “Subparagraph (1) or (2)” and substituting “Subparagraph (1), (2) or (2A)”.
